

ARTICLES OF INCORPORATION

CHICAGO, MILWAUKRE AND ST. PAUL RAILWAY COMPANY OF MONTAGA.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day associated ourselves together for the purpose of incorporating, under the laws of the State of Montana, a corporation to be known by the corporate name of "CHICAGO, MILWAUKEE AND ST. PAUL RAILWAY COMPANY OF LONTANA"; and we hereby certify as follows:

I.

The name of said corporation shall be, "CHICAGO, MILWAUKHE AND ST. PAUL HALLWAY COMPANY OF MONTANA".

(J. .

The purposes for which this corporation is formed are:

(a) To locate, construct, conduct, own, equip, operate, and maintain a railroad, and telegraph line to be used in connection therewith, from some point on the easterly boundary line of the State of Montana, in the County of Custer in said state, which said point is the easterly terminus of said railroad and

westerly direction, through the counties of Custer, Rosebud, Carbon, Yellowstone, Fergus, Meagher, Sweet Grass, Park, Callatin, Broadwater, Jefferson, Madison, Silver Bow, Deer Lodge, Powell, Granite, and Ravalli, in said State of Montana, to some point on the westerly boundary of the State of Montana in said Ravalli County, which said point is the westerly terminus of said railroad and telegraph line aforesaid.

- (b) The carriage of property and persons by express.
- (c) The location, purchase, ownership and operation of coal lands and coal mines.
- (d) The location, appropriation, taking up, and purchase of water power, dam sites, rights of way for fluxes and ditches, for the purpose of generating electricity, and for all other legitimate and proper purposes.

Claiming the right to own, hold, vote, buy, and sell the stock in any other corporation when it is deemed for the interests of the company so to do.

III.

The place where its principal business is to be transacted small be the City of Butte, County of Silver Bow, State of Montana, which shall be its office in the State of Montana.

IV.

The term for which it is to exist shall be twenty (20) years from and after the date of its importantion.

The amount of capital stock of this corporation, which is the amount necessary to construct the road, shall be two million dollars (\$2,000,000.00), divided into twenty thousand (20,000) shares, of the par value of one hundred dollars (\$100) each.


