WOOL SEASON NEARS CLOSE

But 100,000 Pounds More to Be Received.—Mostly Cods, Custer and Park City Clips.

SOME CLIPS WITHDRAWN

This Is in Case Where Price Bid Was Below 16 Cents.—Price Paid Ranges from 16 to 13 1/2.—All the Larger Clips Have Now Been Sold.

All of the 8,000,000 odd pounds received at the Northern Pacific warehouse during a good season, has already arrived with the exception of a 50,000 pound clip, most of which is in the neighborhood of Cody, Custer and Park City.

Just 2,000,000 pounds more remain to be shipped. Some of the clips put up at public sale were withdrawn, when the price bid did not reach 16 cents.

Prices during the last two days ranged from 16 to 13 1/2 cents and several hundred thousand pounds were disposed of at about 16 cents.

The Shupek clip was sold to Jeremiah Williams. This wool amounted to about 80,000 pounds.

The Weirich clip of 100,000 pounds was purchased at Koshland. Silberman and Sons bought in the John C. Tintinger clip of 60,000 pounds, the J. S. Tebbis clip of 15,000 pounds and the J. W. Hoffman clip of 10,000 pounds.

Hecht, Liberman company also bought up the following wool: H. I. R. Sheep company clip of 30,000, McKay Bros. wool of 40,000, A. L. H. H. H. of 20,000, E. Rogness of 20,000 and the Miller Bros. of 60,000 pounds.

The season is rapidly drawing to a close and all the large wool clips have now been disposed of.

ELECTRIC MEN DENY RUMOR

Eastern Montana Company Says Milwaukee Is Not Back of Street Railway.

LET CONTRACT IN FALL

Begin Right of Way and Cross Street Work Near Rockvale. The Proposition Is a \$2,000,000 Affair.—Line Will Extend to Bear Creek.

The Eastern Montana Electric Railway company is doing considerable work these days above Rockvale, on their right of way and across section work.

A New York financier, who has a large interest in the concern, was in the city a few days ago, and expressed himself as being well satisfied with the condition of affairs.

The contract for the work will be let in the fall. It is understood that the company will accept the franchise in good time before the expiration of the 90-day lease limit.

Recently rumors have gained credence about the city to the effect that this company is being controlled by the Milwaukee, which wishes to get the right of way, under guise of a street railway proposition.

This was denied yesterday at the offices of the company in the Stapleton by local representatives. It was positively stated that the Milwaukee has no interest whatever in the franchise.

The work will represent an expenditure of \$2,000,000.

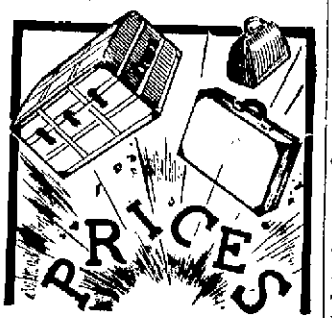
The line, it is proposed, will extend from Billings to Bear Creek, by way of the Clark's Fork country.

MAN CHARGED WITH MURDER

Wyoming Sheriff and Chief Talgo Take Into Custody Man Wanted in Sheridan.

BURIES VICTIM ALIVE

Man's Cries Are Heard.—Is Rescued Only to Die a Few Days Later.—Wife of Alleged Murderer Gives the Sheriff Information.

On a charge of murder in the first degree, Mike E. Lazar of Monarch, Wyo., was arrested in this city yesterday and taken to Sheridan, where he will be held to answer the charge. The killing occurred last Tuesday night in a tent saloon at Monarch and the victim was Steve Karpe. Both men are Hungarians, and it is stated that the trouble between the two men traced back to the time when they lived in the mother country.

Both men were working in the mines at Carneyville and met in the saloon at Monarch. A quarrel ensued. Just what passed between the two men is not known. But at the end of the row, Karpe was disarmed by his opponent's knife, it is stated.

The further allegations are that Lazar buried his victim alive in a pile of shingles nearby, and that Karpe's pitiful groans attracted attention and he was removed and hurried to a hospital. The victim lingered until Friday, when he died. Although conscious part of the time he refused to talk about the case.

Lazar then took leave of his wife and children, telling them where he was going but warning them not to give him away, under penalty of death.

It was understood that Sheriff Benefield learned from the wife that Lazar had come to Billings. Also it is thought that Lazar is wanted for his deeds in the old country.

By means of a letter addressed to his wife from a restaurant in this city, telling her to meet him here, and which letter fell into the sheriff's hands, the latter was enabled to trace his man to this city.

He answered the letter himself, took the train for Billings, met Chief Talgo, and accompanied by the latter went to a local restaurant, where they saw a Hungarian take the letter. This man was cornered and made to lead the way to Lazar who was then apprehended and taken to jail.

Lazar admitted the killing, but says the other man was the aggressor.
